EGLE will be meeting with the Governor's office within the next couple of weeks to review/finalize the last bill draft before it is introduced. MWRA will have an opportunity to comment before introduction. A PFAS section has not been developed, to date, but something is expected to be included. Liz asked Rich and Eric to provide follow-up questions on outstanding issues. EGLE would like a landfill operator to volunteer to host a tour with LSB staff.
